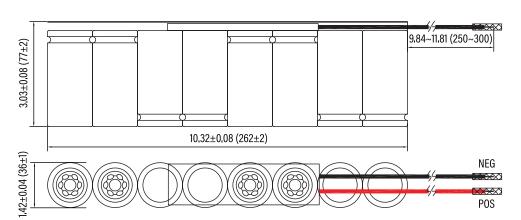

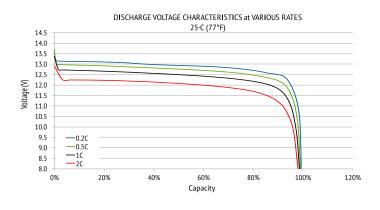

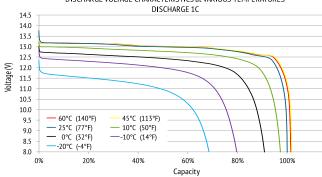

DISCHARGE VOLTAGE CHARACTERISTICS at VARIOUS TEMPERATURES

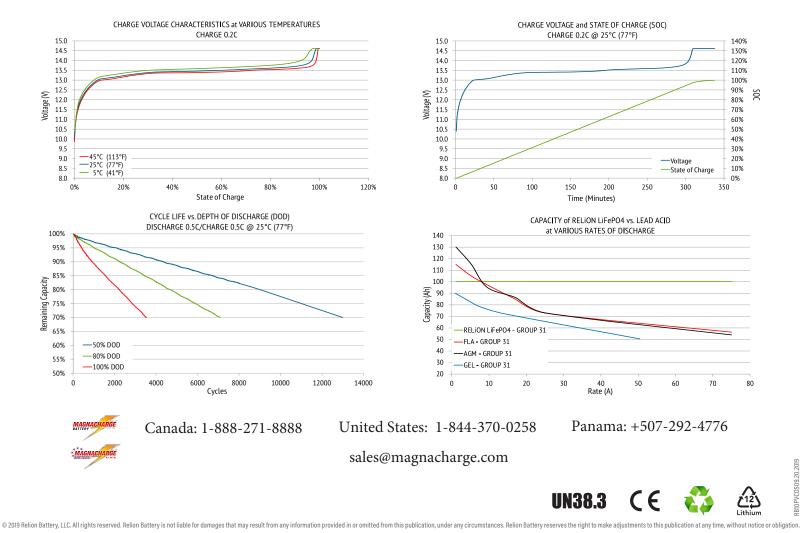
